

## OFFICIAL RULES

NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

- 1. Eligibility:** The Sweepstakes is open only to legal residents of the forty-eight (48) contiguous United States and the District of Columbia who are at least twenty-one (21) years old at the time of entry. Employees of Revolution Beauty Media Group, LLC., and their parent and affiliate companies as well as the immediate family (spouse, parents, siblings and children) and household members (whether related or not) of each such employee are not eligible. Subject to all applicable federal, state, and local laws and regulations. Void in Alaska, Hawaii and where prohibited. How to Enter:** During the Promotion Period, visit <http://www.revolutionbeauty.com> and follow the links and instructions to complete the registration by providing all required information, including where the winner can be contacted on or after the drawing date (specified below). Incomplete, illegible, false or deceptive entries are void. P.O. Boxes are not permitted. You automatically will receive one (1) entry into the Sweepstakes. Limit: Each participant may enter one (1) time only during the Promotion Period. Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entrant's entries and that entrant may be disqualified. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the registrant or player. **5.
